after that of Massey. That the said William Frederick Barton Massey and his issue by the said Isabella Ann Massey may bear the arms of Mainwaring quartered with those of Massey, and that the surname of Mainwaring in addition to and after that of Milman, and the arms of Mainwaring quartered with those of Milman may be borne by the issue of the said Isabella Ann Massey, by her late husband, the said Egerton Charles William Miles Milman; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
