THE SANITARY ACT, 1866, AND THE LOCAL GOVERNMENT BOARD ACT, 1871.

REGULATIONS AS TO LODGING-HOUSES.

WHEREAS, in pursuance of the provisions of the Sanitary Act, 1866, and the Local Govern-ment Board Act, 1871, application has been made to us by the Local Board of the district of Handsworth, in the county of York, as the Nuisance Authority for the district, to declare by notice, to be published in the London Gazette, the enactments contained in the 35th section of the Sanitary Act, 1866, to be in force in the said district:
