Board of Trade (Harbour Department), Whitehall Gardens, August 24, 1874.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Consul General at Tripoli, having reference to the alleged presence of plague on the Barbary Coast, from which it appears that a malignant form of typhus broke out in May last at Merj, a village of about 300 inhabitants, and about 80 miles from Benghasi; that there had been 120 cases and 57 deaths; that the disease had been declared to be plague by Dr. Laval, a Surgeon-Major in the French Army, who, in his efforts to stem the disease, fell a victim to it; that a sanitary cordon

was placed round Merj by the authorities of Benghasi; that outside the cordon two or three cases of plague had occurred; that the fever was attributable to purely local causes, and that it has almost entirely ceased; that the Health Office at Tripoli has placed arrivals from Benghasi and its neighbourhood in fifteen days' quarantine; that the public health at Tripoli is generally good; but that at Malta, Egypt, and Tunis, no arrivals are permitted from any part of the Barbary Coast, and that consequently all means of communication are cut off.

The Board of Trade have also learnt through the Secretary of State for the Colonies that the Board of Health at Gibraltar have decided that arrivals from the Regency of Tripoli be ordered to quit the port forthwith, as well as vessels touching at intermediate ports from the Regency, and also that arrivals from ports eastward of Algiers are to be subjected to the same treatment.
