*Board of Trade, Whitehall Gardens,  
August 31, 1874.*

THE Board of Trade have received from the Secretary of State for Foreign Affairs a copy of a Notification of the Spanish Minister of Finance declaring the following Articles in use on railways to be admissible into Spain free of Customs' duty:—

1. Rails of iron and steel, clamps for joining rails, connecting rods (*tirantes*) to prevent the rails from moving outwards, screws and nails for the permanent way, iron sleepers and the plates for fastening them.
2. Points and crossings of iron and steel.
3. Tires of iron and steel for wheels of locomotives and carriages.
4. Axle-trees of iron and steel for the same.
5. Steel springs for the same.
6. Cast-iron chairs for rails, &c., bars of steel for springs, and pieces of iron for bridges.
