ARTICLE IV .- The Relief Order Book, filled up as above required and signed by the Clerk or the Assistant Clerk, shall be laid before the Board of Guardians at their ordinary meeting, held on the same day as the sitting of the Committee, or at their next ordinary meeting after such sitting, as may be the more convenient; and thereupon the Clerk shall enter on the minutes of the Board of Guardians the fact of the same having been so laid before them.
