Brewood and Wolverhampton Railway (Deviation).

(Deviation and Abandonment of part of Authorised Brewood and Wolverhumpton Bailway : Agree

Brewood and Wolverhampton Railway; Agreements with London and North-Western Railway Company.)

PPLICATION is intended to be made to Parliament in the next session thereof, by the Brewood and Wolverhampton Railway Company (hereinafter referred to as "the Company") for leave to bring in a Bill for the following, or some of the following purposes :—

To enable the Company to make and maintain with all needful works, stations, sidings, approaches, and conveniences connected therewith, a railway in substitution for part of the railway authorised by "The Brewood and Wolverhampton Railway Act, 1874." The said new or substituted railway will be wholly in the county of Stafford, and will commence near the Fordhouses, in the parish of Bushbury, by a junction with the Grand Junction Railway of the London and North Western Railway Company, 340 yards, or thereabouts, north of the post on that railway indicating the 129th mile from London; passing thence through; by, or into Fordhouses, Leescroft, Brindsford, and Coven, and terminating in the township and parish of Brewood by a junction with the authorised Brewood and Wolverhampton Railway, at or near the point shown as I mile and 2 furlongs from the commencement thereof on the plans deposited with the Clerk of the Peace for the county of Stafford in respect of the application for "The Brewood and Wolverhampton Railway Act, 1874."

To enable the Company to abandon the forma-

tion of so much of the said Brewood and Wolverhampton Railway as was authorised to be constructed between the commencement thereof and the said point in the township or liberty of Coven, in the said parish of Brewood, shown on the said plans as 1 mile and 2 furlongs from the commencement thereof.

To enable the Company to cross, divert, alter, or stop up, whether temporarily or permanently, roads, tramways, drains, sewers, pipes, navigations, rivers, streams, and watercourses, so far as may be necessary in constructing or maintaining the said intended railway and works; to deviate from the lines of the railway, as shown on the deposited plans, to any extent within the limits of deviation shown on the said plans, and from the levels of the said railway, as shown on the deposited sections, to any extent to be shown on the said sections or defined by the Bill ; to purchase lands, houses, and other property compulsorily for the purposes of the said intended railway and works ; to levy tolls, rates, and charges in respect thereof, and to exercise other rights and privileges.

To enable the Company on the one hand, and the London and North Western Railway Company on the other hand, from time to time to enter into and carry into effect agreements with respect to the management, construction, and maintenance of the said intended railway, the appropriation and use for the purposes of the intended railway of parts of the land and embankments of the Grand Junction Railway, contiguous to or adjoining the intended railway and works, and to confer upon the Company and the London and North-Western Railway Company respectively the like powers with respect to the said intended new or substituted railway as they have with respect to the Brewood and Wolverhampton Railway.

To authorise the Company to apply their existing funds, and any monics which they have still power to raise, to the purposes of the Bill, and for the same purposes, and for the general purposes of the Company, to raise additional capital by shares or stock, and by borrowing, and to attach to all or any of such shares any guaranteed or preferential dividend, or any other rights or privileges, and otherwise to make provisions with respect to the capital of the Company.

The Bill will vary all existing rights and privileges which would interfere with its objects; and it will incorporate with itself the necessary provisions of the Companies Clauses Acts, 1845, 1863, and 1869; The Lands Clauses Acts, 1845, 1860, and 1869; The Railways Clauses Acts, 1845 and 1863; and it will amend and enlarge, so far as may be necessary, the powers and provisions of "The Brewood and Wolverhampton Railway Act, 1874," and of the 9th and 10th Vic., cap. 210, and any other Acts relating to the London and North-Western Railway Company.
