I do hereby give notice, that it hath been certified to me in writing, under the hands of two Members serving in this present Parliament, that the Honourable George Watson Milles, late a Member serving in this present Parliament for the Eastern Division of the county of Kent, is become a Peer of the United Kingdom, and that a writ of Summons hath been issued to him under the Great Seal of the United Kingdom to summon

him to Parliament, and that I shall issue my Warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said Division of the said county, at the end of six days after the insertion of this notice in the London Gazette.
