N.B.—These Regulations are liable to alteration.

I. The limits of age for these situations are 18 and 30, and Candidates must be of the prescribed age on the first day of the examination.

II. Candidates will be required to show what preliminary training or technical education they have undergone to qualify themselves for a situa-tion of this nature. No Candidate will be eligible who is not serving, or has not within two years been serving as a Clerk (not articled) in a Solicitor's Office.

- 13. Mercantile Book-keeping.
- 14. Equity and Practice of the Courts.
- 15. Bankruptcy and Practice of the Courts.
- IV. A fee of 10s. will be required from each Candidate attending the examination.
