WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Llangammarch, in the county of Brecknock, and in the diocese of Saint David's, and to his successors, Incumbents of the same vicarage, all and singular those annual tithe commutation rent-charges, which are particularly described in the schedule hereunto annexed, and are now vested in us, to have and to hold the said annual tithe commutation rent-charges to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the profits and proceeds of the said tithe commutation rent-charges, for and in respect of the period intervening between the seventh day of July, in the year one thousand eight hundred and seventy-four, and the date of the publication of these presents in the London Gazette.
