

**The Bankruptcy Act, 1869.**

In the London Bankruptcy Court.

In the Matter of John Morgan Deere, of 12, Walbrook, in the city of London, Attorney and Solicitor, a Bankrupt.

Edward Harvey, of 22, Basinghall-street, in the city of London, Public Accountant, has been appointed Trustee of the property of the bankrupt.
