LOCAL GOVERNMENT BOARD.

GENERAL ORDER: Vaccination Contract:—

To the Guardians of the Poor of the several Parishes of Alverstoke, Birmingham, and Brighton, and of the Canterbury Incorporation;

To the Guardians of the Poor within the Town and County of the Town of Southampton; And to all others whom it may concern.

WHEREAS the Guardians of the Poor of the several parishes of Alverstoke, Birmingham, and Brighton, and of the Canterbury Incorporation, and of the town and county of the town of Southampton, being required to enter into contracts with the Medical Officers thereof, or other legally qualified medical practitioners therein, under the provisions of the Vaccination Acts, it is expedient that such contracts should be made in the form hereinafter prescribed;

Now, therefore, we, the Local Government Board, in pursuance of the powers given by the Statutes in that behalf, hereby order that the following form of contract, with such modifications as the said Guardians, with the approval of the Local Government Board, may determine upon, shall be adopted by the said Guardians in making contracts with the Medical Officers of the said

parishes, incorporation, and town respectively, or other legally qualified medical practitioners therein, under the provisions of the Vaccination Acts:—
