The Queen has been pleased to grant unto Cecil Clare Jones, of Gelli Gynan, in the parish of Llanarmon-in-Yale, in the county of Denbigh, Spinster, only child of John Carstairs Jones, of the same place, Esquire, in the Commission of the Peace for the counties of Denbigh and Flint, by Anna Maria Bamford, his first wife, daughter of John Bamford Hesketh, of Bryndalûs, in the said county of Denbigh, Esquire, both deceased, Her Royal licence and authority that she may, in compliance with a direction contained in the last will and testament of Elizabeth Hilton Ford, then the wife of James Hilton Ford, of Bodlondeb, in the parish of Conway, in the county of Carnarvon, Esquire, a Major in the 2nd Regiment of Royal Lancashire Militia, take and use the surname of Ford, in addition to and after that of Jones, and bear the arms of Ford quarterly with those of her own family; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

THE Board of Trade have received from the Secretary of State for Foreign Affairs a copy of a Decree of the Spanish Government, published in the Official Gazette of the 21st ultimo, providing that the import duty on Bessemer steel rails shall be the same as that on iron rails, specified in Division 24 of the Spanish Customs' Tariff, viz. :-8 pesetas per 100 kilogrammes.
