THE Civil Service Commissioners hereby give notice, that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury:—

SPECIAL REGULATIONS (Supplementary to the General Regulations issued 8th April, 1872, and amended by Notices in the London Gazette of the 24th January, 1873, 21st November, 1873, 16th June, 1874, and 5th February, 1875) respecting Open Competitive Examinations for the situation of Estimating Clerk in the Architect's Branch of the Office of Public Works, Ireland.

N.B.—*These Regulations are liable to alteration.*

I. The limits of age for this situation are 22 and 30, and Candidates must be of the prescribed age on the first day of the Examination.

II. Candidates will be required to show what preliminary training or technical education they have undergone to qualify themselves for a situation of this nature, and they must satisfy the Civil Service Commissioners on this point before they can be admitted to the Examination.

III. The Examination will be in the following subjects, viz.:—

1. Handwriting.
2. Orthography.
3. Arithmetic (to Vulgar and Decimal Fractions).
4. The requisite technical knowledge, including an acquaintance with the terms and processes of building, such as to enable the candidate to prepare and examine building accounts.

IV. Candidates failing in any of the above-named subjects will not be eligible.

V. A fee of £1 will be required from each Candidate attending the Examination.

The Civil Service Commissioners further give notice, that an Open Competition for one situation of Estimating Clerk in the Architect's Branch of the Office of Public Works, Ireland, will be held in Dublin, under the above Regulations, on Tuesday, the 5th of October, 1875, and following days.

Persons wishing to be admitted to the Examination should apply at once for the necessary form to the Secretary, Civil Service Commission, London, S.W.
