The Queen has been pleased to approve of Don Francisco Uncilla as Consul at Cardiff for His Majesty the King of Spain.

The Queen has also been pleased to approve of Mr. Robert Andrews as Vice-Consul at Belfast and of Mr. John Richard Tinsly as Vice-Consul at Limerick for His Majesty the Emperor of Austria.
