ORDER issued by the Local Government Board:—

Proceedings under Bastardy Acts. Vaccination: Regulations.

Middlesbrough Union.

To the Guardians of the Poor of the Middlesbrough Union, in the North Riding of the county of York;—

And to all others whom it may concern.

WHEREAS by an Order, bearing date the 1st day of June, 1875, the Local Government Board ordered that certain parishes should, on and after the 25th day of that month, be united for the administration of the laws for the relief of the Poor, and form a Union, to be termed the Middlesbrough Union;

And whereas it is expedient that the provisions of certain General Orders herein-after mentioned should be made applicable to the said Middlesbrough Union:

Now, therefore, We, the Local Government Board, in pursuance of the powers given by the Statutes in that behalf, hereby order as follows; that is to say,—

On and after the twenty-eighth day of July, one thousand eight hundred and seventy-five, the provisions of the Orders hereafter recited shall be applicable to the Middlesbrough Union, and shall be binding upon the Guardians of that Union, and their officers; namely,—

1. The General Order of the Poor Law Board, dated the fifteenth day of February, one thousand eight hundred and sixty-eight, prescribing the form of contract to be entered into for public vaccination.

2. The General Order of the Local Government Board, dated the thirtieth day of November, one thousand eight hundred and seventy-one, prescribing the forms of the notices of requirement of vaccination to be given by Registrars of Births, and the forms of certificates relating to vaccination to be given by Public Vaccinators and Medical Practitioners.

3. The General Order of the Local Government Board, dated the thirty-first day of October, one thousand eight hundred and seventy-four, prescribing regulations with respect to the appointment of Vaccination Officers by Boards of Guardians, the tenure of office, duties, and remuneration of such officers, and the institution and conduct of the proceedings under the Vaccination Acts, and the costs incurred in such proceedings.
