WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, grant and convey to the Incumbent of the vicarage of Great Shelford, in the county of Cambridge, and in the diocese of Ely, and to his successors, Incumbents of the same vicarage, all those annual tenths or payments, amounting to one pound six shillings and eight pence, heretofore payable in respect of the said vicarage, and formerly receivable by the Bishop of Ely, and recently by us, the said Ecclesiastical Commissioners: To have and to hold the said annual tenths or payments to the use of the said Incumbent and his successors for ever.

In witness whereof, we have hereunto set our common seal, this second day of December, in the year one thousand eight hundred and seventy-five.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of a dwelling-house and premises, which has been permanently secured to the vicarage of Saint Paul, Burton-on-Trent, in the county of Stafford, and in the diocese of Lichfield, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said vicarage of Saint Paul, Burton-on-Trent, and to his successors, to meet such benefaction, one yearly sum or stipend of sixty-five pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the fifteenth

day of November, in the year one thousand eight hundred and seventy-five, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
