THE Queen has been pleased to grant unto the Reverend Sydney Turner, M.A., the Deanery of the Cathedral Church of Ripon, void by the resignation of Doctor Hugh McNeile, under the provisions of "The Deans and Canons Resignation Act, 1872."

By virtue of an Act passed in the twentysecond year of the reign of Her Most Gracious Majesty Queen Victoria, intituled "An Act to " extend the Act of the twenty-fourth year of " King George the Third, chapter twenty-six, for " issuing writs during any recess of the House of " Commons, whether by prorogation or adjourn-" ment;" and of an Act passed in the twentysixth year of the reign of Her present Majesty, intituled "An Act to further limit and define the " time for proceeding to Election during the " Recess:"

I do hereby give notice, that it bath been certified to me in writing, under the hands of two Members serving in this present Parliament, in the manner required by the said Act, that Henry Frederick Thynne, Esq. (commonly called Lord Henry Thynne), late a Member serving in this present Parliament for the Southern Division of the county of Wilts, hath accepted the office of Treasurer of Her Majesty's Household, and has been gazetted thereto in the London Gazette, dated the 17th day of December, 1875, and has thereby vacated his seat; and that I shall issue my Warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said Division of the said county, at the end of six days after the insertion of this notice in the London Gazette.
