WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Saint Luke, Holbeach Hurn, in the county of Lincoln, and in the diocese of Lincoln, and to his successors, Incumbents of the same vicarage, all that piece or parcel of land and hereditaments together with the appurtenances thereunto belonging, particularly described in the schedule hereunto annexed, and now vested in us: To have and to hold the said piece or parcel of land and hereditaments with their appurtenances to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same vicarage, shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said piece or parcel of land and hereditaments, for and in respect of the period intervening between the twelfth day of October, in the year one thousand eight hundred and seventy-two, and the date of the publication of these presents in the London Gazette.
