EXPLOSIVES ACT, 1875 (38 Vic, c. 17).

WHEREAS by Section 68 of the above-named Act, it is provided as follows:—

“The Council of any Borough which is assessed to the county rate of any county by the Justices of such county, and the Commissioners of any Im-
