follows that is to say that the four Wards be called the North Ward the South Ward the West Ward and the East Ward.

I direct and order that the

North Ward shall consist of the parish of St. John and so much of the Hamlet of Clase Higher and the Hamlet of Clase Lower, as is within the Borough.

I direct and order that John Glasbrook, Richard Hughes, and William Thomas be the Councillos to represent the North Ward in the Town Council.

I direct and order that the

South Ward shall consist of that portion of the Borough included in the following area viz., from the middle of the old bed of the River Tawe now known as the North Dock along the Strand Row to the point at which the same meets the Strand thence southward along the Strand to the point at which the same meets Welcome Street thence along Welcome Street to the point at which the same meets College Street thence along College Street to the point at which the same meets Gower Street thence along Gower Street to the point at which the same meets Heathfield Street thence along Heathfield Street to the point at which the same meets Northampton Place thence along Northampton Place to the point at which the same meets St. Helen's Road thence along St. Helen's Road to the point at which the same meets Brynmor Road then along Brynmor Road to the point at which the same meets the Gower Turnpike Road thence along the Gower Turnpike Road to the point at which the same crosses the boundary of the Borough near the Sketty Church thence southward along the boundary of the Borough to the point at which the same joins Swansea Bay thence eastward along Swansea Bay to the mouth of the River Tawe thence northward along the River Tawe and North Dock to the point first named.

I direct and order that John Buie, Frank Ash Yeo, James Livingston, James Rogers, Benjamin Rose Harvey, and Lawrence Tallock be the Councillors to represent the South Ward in the Town

Council.

I direct and order that the

West Ward shall consist of the remaining part of the Town and Franchise not included in the South Ward.

I direct and order that Thomas Elford, William Richards, William Rees, John Ivor Evans, Edward Rice Daniel, and Thomas Glasbrook be the Councillors to represent this Ward in the Town Council.

I direct and order that the

East Ward shall consist of the Hamlet of St. Thomas and so much of Llansanlet Higher and Llansanlet Lower as is within the Borough.

I direct and order that Charles Roberts Glover, Thomas Davies, and Marcus Moxham be the Councillors to represent the East Ward in the Town Council.

HEREAS by the 46th Section of the Merchant Shipping Act Amendment Act, 1862, it is enacted that if any lighthouse, buoy, or beacon is erected or placed, or re-constructed, repaired, or replaced, by any local authority having jurisdiction in the matter of lighthouses, buoys, or beacons, Her Majesty may, on the application of the said local authority, by Order in Council, fix such dues to be paid to the said local authority in respect of every ship which enters the port or harbour under the jurisdiction of such local authority, or the estuary wherein such lighthouse, buoy, or beacon is situate, and which passes the said lighthouse, buoy, or beacon, and derives benefit therefrom, as Her Majesty may deem reasonable:

And whereas by the 47th Section of the said Act it is enacted that Her Majesty may, by Order in Council, and subject to certain conditions, from time to time reduce, alter, or increase all or

any of such dues:

And whereas the Corporation of the Trinity House in Kingston-upon-Hull, hereinafter called the Hull Trinity House, being the local authority having jurisdiction in the matters hereinafter mentioned, did, previously to the month of November, 1862, erect and exhibit four beacons, each carrying a light, whereof two are on the west side of Whitton Ness, in the parish of Whitton, in the county of Lincoln, and two on the east side of the said Ness, in the parish of Winteringham, in the said county, and did also place a buoy in the River Humber off Whitton Ness aforesaid:

And whereas by an Order in Council, dated the 1st day of November, 1862, Her Majesty, in exercise of the powers vested in Her by the said recited Act, was pleased to direct that there should be paid to the Hull Trinity House certain dues in respect of every ship which being in the River Humber should pass and derive benefit from the said beacons, lights, and buoy, or any of them:

And whereas the Hull Trinity House have placed and are now exhibiting a floating light in the River Humber, off Whitton Ness, in lieu of the said buoy, and have also erected and are now exhibiting eight additional beacons, each carrying a light, whereof one is at Chaldersness, two are at Brough, two on the pier at Whitton, two on the two stone heaps in Walker Dyke, and one is at Faxfleet; and they have represented that provision should be made for the maintenance of the said floating light and the said additional eight lights, and have submitted that the dues which are now leviable under the said Order in Council of 1862 in respect of the four lights and the buoy therein mentioned should on and after the date of the present Order in Council cease to be leviable, but that like dues should be leviable in respect of the said floating light, the said four lights, and the said eight new lights (or any of them):

And whereas it has been made to appear to Her Majesty that the application is reasonable and
