Settlements whilst acting as Resident in a neighbouring Malay State, and the disorders ensuing on that outrage, have demanded the interference of any troops. I trust that the operations, which have been ably and energetically conducted, though not without the loss of some valuable lives, have restored order and re-established the just influence and authority of this country.

Gentlemen of the House of Commons,

I have directed the Estimates of the year to be prepared and presented to you without delay.

My Lords and Gentlemen,

Bills for regulating the Ultimate Tribunal of Appeal for the United Kingdom, and for the Amendment of the Merchant Shipping Laws, will be immediately submitted to you.

Legislation will be proposed relating to the Universities and to Primary Education.

Your attention will be called also to the Acts relating to the Inclosure of Commons, and to a measure for promoting economy and efficiency in the management of Prisons, and at the same time effecting a relief of local burthens.

Other important measures, as the time of the session permits, will be introduced to your notice; and I pray that your deliberations may, under the Divine blessing, result in the happiness and contentment of my people.

The Noblemen and Gentlemen, who propose to attend Her Majesty's Levee, at St. James's Palace, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented, must leave at the Lord Chamberlain's Office, St. James's Palace, *before twelve* o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulations that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that an intimation from the Nobleman or Gentleman who is to make the presentation, of his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is

Her Majesty's command that no presentations shall be made at the Levee, except in accordance with the above regulations.

It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to His Royal Highness.
