Holdenhurst annexed all which said portion of such chapelry is bounded on the north and on the east by the main portion of the parish of Christ Church aforesaid on the south-east by the new parish of Pokesdown in the said county and diocese on the south-west partly by the last-named cure partly by the new parish of Saint Clement, Bournemouth, and partly by the new parish of the Holy Trinity Bournemouth both in the county and diocese aforesaid, and on the remaining side that is to say on the west by the new parish of Saint John Moordown in the same county and diocese.

"And also all that part of the said parish of Christ Church which is situate on the western side of Hadden's Hill Plantation and which being surrounded upon all sides by the portion of the chapelry of Holdenhurst above described lies detached and isolated from the main portion of the parish of Christ Church aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocess of Winchester.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the twentieth day of January, in the year one thousand eight hundred and seventy-six, in the words and figures following; that is to say,

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint Peter situate at Cowleigh, within the limits of the new parish of Saint James Mathon which said new parish is situate partly in the county of Worcester, and partly in the county of Hereford and wholly in the diocese of Worcester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Peter situate at Cowleigh as aforesaid."

"Now therefore, with the consent of the Right Reverend Henry Bishop of the said diocese of Worcester (testified by his having signed and 1876, No. 2,' and placed at the south-eastern end'

sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said new parish of Saint James, Mathon which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint Peter, situate at Cowleigh as aforesaid, and that the same should be named 'The District Chapelry of Saint Peter. Cowleigh.

Chapelry of Saint Peter, Cowleigh. "And with the like consent of the said Henry Bishop of the said diocese of Worcester (testified as aforesaid), we, the said Egclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always. that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"We, therefore, humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order with respect thereto as to your Majesty, in your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Peter, Cowleigh, being:

"All that part of the new parish of Saint James Mathon situate partly in the county of Worcester and partly in the county of Hereford and wholly in the diocese of Worcester, which is bounded on the south by the new parish of the Holy Trinity Great Malvern in the said county of Worcester and in the diocese of Worcester aforesaid, on the east partly by the last-named new parish and partly by the new parish of Saint Matthias at the Link in the same county and diocese on the north by the last-named new parish and on the remaining side that is to say on the west partly by the new parish of Saint John the Evangelist at Storridge in the said county of Hereford, and in the diocese of Hereford and partly by an imaginary line commencing upon the boundary which divides the last-named new parish from the new parish of Saint James Mathon aforesaid at a point in the middle of the road leading from Saint Peter's Church Cowleigh to Birches Gate such point being at a distance of two hundred and ninetytwo yards or thereabouts measured along such road to the west of its intersection by the road leading from Cowleigh Farm to Malvern and opposite to a boundary stone inscribed 'C. St. P. D. C. 1876, No. 1, and placed on the south-eastern side of the same road at the north-western end of a certain wall which intersects the close called Lower Meadow and numbered 1667 on the tithe commutation map of the parish of Cradley in the last-named county and diocese and extending thence that is from the said first-described point south-eastward to such boundary stone and continuing thence in the same direction for a distance of ninety yards or thereabouts along the said wall
