(enclosing: his certificate of service, or an attested copy thereof, excepting in the case of Commissioned Officers); in which letter his own place of residence is to be precisely stated, as well as the place of the nearest Collector of Customs, or of Inland Revenue, from whom it would be convenient to receive such share of prize money.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of one thousand pounds sterling, which has been paid to us in favour of the vicarage of Saint Augustine, Pendlebury, in the county of Lancaster, and in the diocese of Manchester, and in respect of which we have agreed to pay to the Incumbent of the same vicarage, and to his successors, a yearly sum of thirty-three pounds six shillings and eightpence, and in consideration also of a further benefaction consisting of a certain house and premises formerly belonging to the vicarage of Christ Church, Pendlebury, in the same county and diocese, which has been transferred and permanently secured to the said vicarage of Saint Augustine, Pendlebury, do hereby, in pursuance of the Act of the twenty-ninth and chirtieth years of Her Majesty, chapter one fundred and eleven, section five, grant to the Incumbent of the said vicarage of Saint Augustine, Pendlebury, and to his successors, to meet the said benefactions, one yearly sum or stipend of fifty pounds, such yearly sum or stipend to be payable out of the common fund under our

control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal halfyearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the yearly sum or stipend so payable out of our common fund, as lastly herein mentioned, or any part thereof, shall be annexed by us to the said vicarage of Saint Augustine, Pendlobury, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
