Preston Tramways Bill.

Alteration of Works and Plans.

NOTICE is hereby given, that it is intended to alter the tramways described in section 5 of the Preston Tramways Bill, now pending in the House of Commons, in the manner hereinafter mentioned, viz:—

Tramway No. 1 (single line), 2 miles 6 furlongs 8.60 chains in length, commencing in Christ Church Ward, in the parish of Preston, at a point in Fishergate about nine yards northward and in line with the east side of Charles-street, and terminating in the township of Fulwood, in the parish of Lancaster, at a point in Watling-street about ten yards northward and in line with the east side of the Prince Albert Inn, all of which tramways are in the parishes of Preston and Lancaster.

Will be altered and be as follows:—

Tramway No. 1 (single line), 2 miles 3 furlongs 2.40 chains in length, commencing in Lancaster-road South, Trinity Ward, in the parish of Preston, in line with the north face of houses in Church-street, and terminating in the township of Fulwood, in the parish of Lancaster, at a point in Watling-street about ten yards northward and in line with the east side of the Prince Albert Inn, all of which tramways are situate in the parishes of Preston and Lancaster.
