NOTICE TO MARINERS.

(No. 53.)—CANADA—GULF OF ST. LAWRENCE.

Fixed Green Light, Poemouche Gully.

THE Government of the Dominion of Canada has given notice, that on the opening of navigation in 1876, a light will be exhibited from a lighthouse recently erected at Poemouche Gully, Gulf of St. Lawrence.

The light is a *fixed green* light, elevated 35 feet above the level of high water, and in clear weather should be seen from a distance of 8 miles.

The illuminating apparatus is catoptric or by reflectors.

The tower, 37 feet high, is a square wooden building painted white, and attached to the keeper's dwelling. Position, lat. $47^{\circ} 40' N.$, long. $64^{\circ} 46' W.$

NOTICE TO MARINERS.

(No. 54.)—BLACK SEA—KERTCH STRAIT.

Fixed Light on Kyz Aul Point.

THE Russian Government has given notice, that from the 1st May, 1876, a light will be exhibited from a lighthouse recently erected on

Kyz Aul (Kos Aul) Point, west side of the entrance to Kertch Strait.

The light will be a *fixed white* and *green* light, showing white between the bearings of west, through north, and N.E. by E. $\frac{1}{2}$ E.; and green from N.E. by E. $\frac{1}{2}$ E. to E. by N. $\frac{3}{4}$ N., also between west and W. by S. $\frac{3}{4}$ S. The sector of green light seen from the westward covers the Ilchan Kai Rocks; and that seen from the eastward the Kishla Reef and Highflyer Rock.

The light is elevated 203 feet above the level of the sea, and in clear weather should be seen from a distance of 20 miles.

The illuminating apparatus is dioptric or by lenses, of the first order.

The tower, 79 feet high, is built of stone, and painted black and white in vertical stripes. Two houses are close to its eastern side. Position, lat. $45^{\circ} 3' 40'' N.$, long. $34^{\circ} 2' 15'' E.$

NOTE.—When nearing Kyz Aul Point from the westward vessels must keep in the limit of the white light. When entering or leaving Kertch Strait, St. Paul light should be kept in sight when crossing the eastern green sector of Kyz Aul light, to clear the dangers off Cape Takli and Kishla Point.

Discontinuance of Cape Takli Light.

Also, that from the 1st May, 1876, the light now exhibited on Cape Takli, Kertch Strait, will be discontinued.

[All bearings are magnetic. Variation $1\frac{1}{2}^{\circ}$ Westerly in 1876.]
