WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Aberdovey, in the county of Merioneth, and in the diocese of Bangor, and to his successors, Incumbents of the same vicarage, all and singular the annual tithe commutation rent-charges which are particularly described in the schedule hereunto annexed, and are now vested in us: To have and to hold the said annual tithe commutation rent-charges to the use of the said Incumbent and his successors for ever: Provided always, that the said annual tithe commutation rent-charges, expressed to be hereby granted and conveyed shall be, and be taken to be, in lieu of and in full substitution for the yearly sum or stipend of twenty pounds heretofore paid by us, the said Commissioners, to the Incumbent of the said vicarage of Aberdovey, and also for certain capital sums amounting to one thousand eight hundred and nineteen pounds six shillings and seven pence, held by us, the said Commissioners, to the credit of the said vicarage, in respect of which capital sums we are now paying to the Incumbent of the said vicarage annual sums amounting to fifty-nine pounds seven shillings and ten pence: And provided also, that the Incumbent for the time being of the same vicarage shall be entitled to receive from us, or on our account, the net amount of the profits and proceeds of the said annual tithe commutation rent-charges for and in respect of the period intervening between the twenty-fifth day of March, in the year one thousand eight hundred and seventy-five, and the date of the publication of these presents in the London Gazette.

In witness whereof we have hereunto set our common seal this thirteenth day of July in the year one thousand eight hundred and seventy-six.
