"Whereas it appears to us to be expedient that a district for spiritual purposes should be set out and constituted for and annexed to the said church of Saint Clement, Longsight, situate within the limits of the new parish of Saint Matthew Ardwick as aforesaid.

"Now therefore with the consent of the Right Reverend James Bishop of the said diocese of Manchester, testified by his having signed and sealed this scheme we humbly recommend and propose that all that portion of the said new parish of Saint Matthew Ardwick, and also all that contiguous portion of the new parish of Saint Stephen Chorlton-upon-Medlock (also sometime part of the original parish of Manchester aforesaid) portions are described in the all which written, and are delischedule hereunder neated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme be severed and disannexed from such new parishes respectively and shall be set out and constituted for and annexed to the said church of Saint Clement, Longsight, situate within the limits of the new parish of Saint Matthew Ardwick, as aforesaid, and shall become and be a district for spiritual purposes and shall be named 'The District of Saint Clement Longsight.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or to any of them, in accordance with the provisions of the hereinnamed Acts or of either of them, or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Clement, Longsight,

being:—
"All that portion of the new parish of Saint
"All that portion of the original limits of Matthew, Ardwick, within the original limits of the parish of Manchester in the county of Lancaster and in the diocese of Manchester which is bounded on the north-east by the new parish of Saint Mark Gorton on the south-east by the new parish of Saint John Longsight, and on the greater part of the south-west by the new parish of Saint Stephen Chorlton-upon-Medlock all within the original limits of the parish of Manchester aforesaid and upon all other sides that is to say on the remaining portion of the south-west and on the north-west by an imaginary line commencing at a point in the middle of Grey-street distant nine and a half-chains or thereabouts from the junction of the same street with the Stockport and Londonroad, at which point the boundary dividing the said new parish of Saint Stephen Chorlton-upon-Medlock from the new parish of Saint Matthew Ardwick aforesaid, crosses the boundary which divides the township of Ardwick from the township of Gorton, both which townships are within the original limits of the parish of Manchester aforesaid and extending thence that is to say from the said point in the middle of Grey-street as aforesaid first north-westward and then north-eastward along the said township boundary to the point in the middle of the line of the London and North-Western Railway where the same town-ship boundary crosses the boundary which divides the said new parish of Saint Matthew Ardwick from the new parish of Saint Mark Gorton aforesaid.

"And also all that contiguous portion of the said new parish of Saint Stephen Chorlton-upon-Medlock which is bounded on part of the south-

west and on the south-east by the new parish of Saint John Longsight aforesaid, on the north-east by the above-described portion of the new parish of Saint Matthew Ardwick aforesaid on the northwest by other portions of the same new parish and upon the remaining part of the south-west by an imaginary line commencing upon the boundary which divides the said new parish of Saint Matthew Ardwick from the new parish of Saint Stephen Chorlton-upon-Medlock aforesaid at the point where Grey-street aforesaid is joined by Baker-street and extending thence south-eastward for a distance of seven and a half chains or thereabouts along the middle of the last-named street to its junction with John-street and continuing thence precisely in the same direction and in a straight line for a distance of four chains or thereabouts to a point in the middle of Ducie-street and extending thence south-westward for a distance of four chains or thereabouts along the middle of the lastnamed street to its junction with the Stockport and London-road aforesaid, and extending thence south-eastward for a distance of thirteen and a half chains or thereabouts along the middle of the last-named road to the boundary at the junction of the same road with Grindlow-street which boundary divides the said new parish of Saint Stephen Chorlton-upon-Medlock from the new parish of Saint John Longsight aforesaid."

And whereas drafts of the said scheme have in accordance with the provisions of the hereinbefore firstly mentioned Act, been transmitted to the patrons and to the incumbents of the two cures out of which it is intended that the district in such scheme recommended to be constituted shall be taken and such patrons and incumbents have respectively signified their assent to the said scheme.

And whereas the said scheme has been approved by Her Majesty in Council: now therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester.
