The QUEEN's Most Excellent Majesty in Council.

IT is this day ordered by Her Majesty in Council that the Parliament be prorogued from Tuesday, the fifteenth day of August instant, to Tuesday, the thirty-first day of October, one thousand eight hundred and seventy-six; and that the Right Honourable the Lord High Chancellor of that part of the United Kingdom called Great Britain do cause a Commission to be prepared and issued in the usual manner for proroguing the Parliament accordingly.

IT is this day ordered by Her Majesty in Council that the Convocations of the Provinces of Canterbury and York be prorogued from the day to which the same now stand prorogued to Wednesday, the first day of November, one thousand eight hundred and seventy-six; and the Right Honourable the Lord High Chancellor of that part of the United Kingdom called Great Britain is to cause Writs to be prepared and issued in the usual manner for proroguing the Convocations accordingly.

WHEREAS the New Governing Body of Winchester School, in virtue of the powers conferred upon them by "The Public Schools Act, 1868," and of every other power enabling them in that behalf, did, on the second day of August, one thousand eight hundred and seventy-six, make certain amendments in the Statutes for the government of that School, approved by Her Majesty in Council on the twentieth November, one thousand eight hundred and seventy-three:

And whereas the said amendments have been this day laid before Her Majesty in Council, the same are published in the London Gazette, in pursuance of the provisions of the said Act.

And notice is hereby given, that it is lawful for the bodies or persons authorized so to do, in that Act, within two months from the date of the publication of this notification, to petition Her Majesty in Council to withhold Her approval from the whole or any part of such amendments of the Statutes.

Amendments in Statutes.

STATUTE X.

Sect. 1. To omit the words "the vacant" in the first line.

After Sect. 3 to insert (as a new paragraph) as follows:—

Such number of scholars shall be elected in each year as shall be equal to the number of scholarships which are vacant on the day of election, or must, under the statutes and regulations in force for the time being, become vacant on or before the 10th of January then next following.

To amend Sect. 5 so as to run thus:—

Any boy may be a candidate for a scholarship in any year whose age on the 1st of June in the same year shall not be less than 12 nor more than 14 years. Every candidate, &c.
