A T the Court at Osborne House, Isle of Wight, humbly recommend and propose that upon and from the l2th day of August, 1876.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the thirty-third and thirty-fourth years of Her Majesty chapter thirty-nine duly prepared and laid before Her Majesty in Council a scheme, bearing date the third day of August, in the year one thousand eight hundred and seventy-six, in the words and figures following, that is to say :

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the thirtythird and thirty-fourth years of your Majesty chapter thirty-nine have prepared and now humbly lay before your Majesty in Council the following scheme for effecting a prospective transfer of the ownership of the advowson or 'perpetual right of patronage of and to the church and cure (which said church and cure are hereinafter called the said benefice) of Saint Mary at Kilburn in the county of Middlesex and in the diocese of London.

"Whereas the advowson or perpetual right of patronage of and to the said benefice of Saint Mary at Kilburn is vested for an estate for life in possession in the Honourable Arthur Upton a General in your Majesty's Army and is vested in remainder expectant upon the determination of that estate in the Bishop for the time being of the said diocese of London and his successors. "And whereas certain persons have paid to the

⁶⁴ And whereas certain persons have paid to the credit of our account at the Bank of England a sum of one thousand and one hundred pounds for the benefit of the said benefice of Saint Mary at Kilburn but upon condition that the transfer of the patronage of the same benefice which is hereinafter recommended and proposed shall be effected, and it has been made to appear to us that by means of the said sums so paid to us and of other monies and of certain land now being conveyed to us by way of gift, a house of residence for the incumbent of the said benefice can and will be provided to our satisfaction forthwith which house will be of the value of not less than two thousand pounds and will stand upon a site (being the land aforesaid) valued at one thousand pounds.

"And whereas under the circumstances lats aforesaid the Right Honourable and Right Reverend John, now Bishop of the said diocese of London is willing that the transfer of the patronage of the said benefice of Saint Mary at Kilburn which is hereinbefore mentioned and is hereinafter recommended shall be effected; and he the said hishop hath accor lingly executed this scheme as hereinafter is mentioned in token of such his willingness, and also in token that the same transfer has that consent of the Bishop of the diocese which hy the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary.

"And whereas it appears to us that under the circumstances above set forth the transfer of the patronage of the said benefice of Saiut Mary at Kilburn which is hereinbefore mentioned and is hereinafter recommended and proposed will tend to make better provision for the cure of souls in the district chapelry and new parish of Saint Mary at Kilburn aforesaid being the parish or district in or in respect of which the said right of patronage and advowson arises and exists.

"Now therefore with the consent of the said John Bishop of the said diocese of London (in testimony whereof he has signed this scheme and scaled the same with his episcopal scal) we

from the day of the date of the determination of the said estate of the said Arthur Upton in the advowson of the said benefice of Saint Mary at Kilburn, the whole advowson and perpetual right of patronage now as a oresaid vested in the Bishop of the said diocese of London and his successors in remainder expectant upon the determination of the same estate of and to the said benefice of Saint Mary at Kilburn shall without any conveyance or assurance in the law other than any duly gazetted Order of your Majesty in Council ratifying this scheme be transferred from the said. John Bishop of the said diocese of London or other the then Bishop of the same diocese and from his successors and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised jointly by the five persons next hereinafter named that is to say, the Honourable and Right Reverend John Thomas Pelham now Bishop of the diocese of Norwich, the Reverend Edmund Hollond of Benhall Lodge Benhall in the county of Suffolk Clerk in Holy Orders, the Reverend Henry Wright of Heath House, Hampstead in the said county of Middlesex Clerk in Holy Orders, Francis Augustus Bevan. of No. 59 Princes-gate Hyde Park, in the said county of Middlesex Esquire, and John George Sheppard of Campsey Ashe in the said county of Suffolk, Esquire, and their heirs and assigns; which said five persons have been duly nominated to us by or on behalf of the donors of the said sum of one thousand and one hundred pounds as the persons in whom, and in their heirs and assigns, they the said donors desire that the said advowson and patronage shall. be vested as aforesaid.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of. Parliament."

And whereas the suid scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.
