#### Downing Street, August 29, 1876.

The Queen has been pleased to appoint Lieutenant-Colonel Francis Edward Pratt, R.E., to be a Member of the Executive Council of the Colony of Fiji.

By virtue of an Act passed in the twentyfourth year of the reign of His Majesty King George III, intituled "An Act to repeal so "much of two Acts made in the tenth and "fifteenth years of the reign of His present "Majesty, as authorizes the Speaker of the "House of Commons to issue his Warrant to "the Clerk of the Crown for making out writs "for the election of Members to serve in Par-"liament, in the manner therein mentioned, and "for substituting other provisions for the like "purposes;" and of an Act passed in the twentysixth year of the reign of Her present Majesty, initialed "An Act to further limit and define "the time for proceeding to Election during the "Recess."

I do hereby give notice, that it hath been certified to me in writing, under the hands of two Members serving in this present Parliament, that the Right Honourable Benjamin Disraeli, late a Member serving in this present Parliament for the county of Buckingham, is become a Peer of the United Kingdom, and that a writ of Summons hath been issued to him under the Great Seal of the United Kingdom to summon him to Parliament, and that I shall issue my Warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for said county, at the end of six days after the insertion of this notice in the London Gazette.
