The Queen has been pleased to sanction the appointment of Captain George Cumine Strahan, R.A., C.M.G. (late Governor and Commander-in-Chief of the Gold Coast Colony), to be Governor and Commander-in-Chief of the Islands of Barbados, Grenada, St. Vincent, Tobago, and St. Lucia, and their dependencies.

The Queen has been pleased to sanction the appointment of Sanford Freeling, Esq., C.M.G. (late Lieutenant-Governor of the Island of Grenada), to be Governor and Commander-in-Chief of the Gold Coast Colony.

The Queen has been pleased to grant the office of Solicitor-General for Scotland to John Hay Athole Macdonald, Esq., Advocate, in the room of William Watson, Esq., appointed Her Majesty's Advocate for Scotland.

Whitehall, November 20, 1876.

The Queen has been pleased to grant unto Frederick Vaughan, of Combe Grove, in the parish of Monkton Combe, in the county of Somerset, Gentleman, third and youngest but now only surviving son of William Vaughan, late of Combe Grove aforesaid, Esquire, deceased, Her Royal licence and authority that he and his issue may, in compliance with a clause contained in the last will and testament of his father, the said William Vaughan, deceased, take and henceforth use the surname of Jenkins, in addition to and after that of Vaughan, and that they may bear the arms of Jenkins quarterly with those of Vaughan; such arms being first duly exemplified according to the laws of arms and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
