## THE FAIRS ACT, 1871.

## ACLE FAIR.

IN pursuance of the above-mentioned Act, I, the Right Honourable Richard Assheton Cross, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:

1. A representation has been duly made to me by the Right Honourable the Lord Calthorpe, as owner, that a Fair has been annually held in the parish of Acle, in the county of Norfolk, on the 24th and 25th days of June, and that it would be for the convenience and advantage of the public that such Fair should be abolished.

2. On the 1st day of May, 1877, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.
