And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Vice-Consul at Dakar, stating with reference to the recent Decree of the Governor of Senegal (copy of which appeared in the London Gazette of the 24th instant), that steamers, both French and foreign,

which touch at Dakar merely for coaling purposes will be exempt from light dues, and will only be required to pay the health dues.
