"Cloths called guineas, manufactured in France, or in the French establishments of India, will pay on their entry at Saint Louis (Senegal) a duty of 4 centimes per mètre when they shall have been stamped by the Customs Service in France or at Pondicherry. Guinea cloths of other origin will, in addition, be subjected to a supplementary duty of 8 centimes per mètre."
