THE Queen has been pleased to give and grant to Richard Atkinson, of St. John's College, in the University of Oxford, Clerk, Master of Arts, Vicar of Cockerham, in the county palatine of Lancaster, Her Royal licence and authority that he and his issue may, in compliance with a proviso contained in the last will and testament of Edmund Grimshaw, of Lincoln's Inn, in the county of Middlesex, and of Pierremont, in or near Broadstairs, in the Isle of Thanet, in the county of Kent, Esquire, Barrister-at-Law, deceased, henceforth take and use the surname of Grimshaw, in addition to and after that of Atkinson, and bear the arms of Grimshaw quarterly, in the first quarter with those of Atkinson; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and none effect:

And also to command that the said Royal concession and declaration be registered in Her Majesty's College of Arms.
