become should be assigned in manner hereinafter

recommended and proposed.

"Now, therefore, with the consent of the Right Honourable and most Reverend Archibald ·Campbell Archbishop of Canterbury (in testimony whereof he has signed and sealed this scheme, we the said Ecclesiastical Commissioners for England humbly recommend and propose that all that part of the said parish of Charlton-by-Dover which is mentioned and described in the Schedule hereunder written, and which is delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme become and be constituted a separate District for spiritual purposes and that the same shall be named 'The District of Saint Bartholomew Charlton-by-Dover.

"And we further recommend and propose that the whole right of patronage of the said district so recommended to be constituted and of the nomination of the incumbent thereto, or (as the case may be) of the incumbent of the new parish which such district will or may hereafter become shall without any assurance in the law other than this Scheme and any duly gazetted order of your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in and shall and may from time to time be exercised by the Warden Council and scholars of Keble College in the University of Oxford and their successors and assigns for

· "And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in conformity with the provisions of the said Acts, or of either of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Bartholomew Charl-

ton-by-Dover, being "All that part of the parish of Charlton by Dover in the County of Kent and in the Diocese of Canterbury which is bounded on the north and on the north-west by the parish of Buckland in the said county and diocese, and on the south partly by the Parish of Hougham partly by the new Parish of Christ Church Hougham in Dover and partly by the Parish or Parochial Chapelry of Saint Mary the Virgin Dover all in the county and diocese aforesaid, and on the remaining side, that is to say on the north-east, by an imaginary line commencing upon the boundary which divides the last-named parish or parochial chapelry from the Parish of Charlton-by-Dover aforesaid at a point in the middle of the High-street in the Town of Dover opposite to the north-eastern end of the roadway called or known as Trafalgar-place, and extending thence north-westward for a distance of three hundred and fifty-seven yards or thereabouts along the middle of the said High-street to its junction with Tower Hamlets-road with Bridge-street and with the London-road and continuing thence still north-westward for a distance of two hundred and thirty-eight yards or thereabouts along the middle of the lastnamed road to the boundary which divides the said Parish of Charlton-by-Dover from the Parish of Buckland aforesaid."

And whereas drafts of the said Scheme have. in accordance with the provisions of the secondly hereinbefore mentioned Act, been transmitted to the patrons and to the incumbent of the rectory of the said Parish of Charlton-by-Dover out of which parish it is intended that the district recommended in such Scheme to be constituted shall be taken, and such patrons and incumbent have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by Her Majesty in Council: Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Canterbury.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, and of the Act of the nineteeth and twentieth years of Her Majesty, chapter one hundred and four, duly prepared and laid before Her Majesty in Council a Scheme, bearing date the eight day of November, in the year one thousand eight hundred and seventyseven, in the words following, that is to say;
"We the Ecclesiastical Commissioners for

England in pursuance of the Act of the third and fourth years of your Majesty chapter one hundred and thirteen, of the Act of the sixth and seventh years of your Majesty chapter thirtyand seventh years of your majesty chapter thirty-seven, and of the Act of the nineteenth and twentieth years of your Majesty chapter one hundred and four, have prepared and now humbly lay before your Majesty in Council the following Scheme for constituting a separate district for spiritual purposes to be taken out of the new Parish of Bierley out of the new Parish of Whitechapel out of the new Parish of Wike out of the new Parish of Birkenshaw-cum-Hunsworth and out of the Parochial Chapelry of Wibsey, all which said cures are situate in the County of York and in the Diocese of Ripon.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular portions of the said new Parish of Bierley, of the said new Parish of Whitechapel of the said new Parish of Wike, of the said new Parish of Birkenshaw-cum-Hunsworth and of the said Parochial Chapelry of Wibsey which are hereinafter mentioned and described should be constituted a separate district in manner hereinafter recommended and proposed.

"And whereas there is not at present within. the limits of the said proposed district any consecrated church or chapel in use for the purposes of Divine Worship.

"And whereas for the purpose of providing an endowment for the said proposed district a
