said Parish of Spalding and of the said Parish of Pinchbeck and of the said Parish of Surfleet which are described in the schedule hereunder written all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this Scheme become and be constituted a separate district for spiritual purposes and that the same shall be named "The District of Saint Paul, Spalding."

"And we further recommend and propose that the whole right of patronage of the said proposed district and of the said new parish if and when such district shall have become a new parish as aforesaid and of the nomination of the minister or incumbent thereof shall without any assurance in the law other than this scheme and any duly Gazetted Order of your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such order in the London Gazette as aforesaid be assigned to and be absolutely vested in and shall and may be exercised by the said Charlotte Charinton during her life and that from and after the day of the date of her death the whole remaining right of patronage of the said district or new parish and of the nomination of the minister or incumbent thereof shall in like manner be assigned to and become absolutely vested in and shall and may from time to time be exercised jointly by the said Christopher Bishop of the said Diocese of Lincoln and by his successors bishops of the same diocese for ever and by the Reverend Edward Moore, vicar or incumbent of the vicarage of the said Parish of Spalding, and by his successors vicars or incumbents of the same vicarage for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Paul, Spalding, being:-

"All that portion of the Parish of Spalding in the County of Lincoln and in the Diocese of Lincoln, and also all those contiguous portions of the Parish of Pinchbeck and of the Parish of Surfleet both in the county and diocese aforesaid which said portions of such parishes are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the said Parish of Pinchbeck from the Parish of Spalding aforesaid at a point in the middle of Vernatt's drain opposite to the northern end of the dyke upon the western side of the bank or roadway called or known as the Old Roman Bank and extending thence southward for a distance of forty-five chains or thereabouts to and along the middle of the said dyke to a point where it strikes the western bank of the River Welland and extending thence eastward and in a direct line for a distance of two chains or thereabouts to a point in the middle of the said river and extending thence southwestward for a distance of fifteen chains or thereabouts along the middle of the same river to its junction at Allam's Tunnel with Exeter Drain and extending thence southward for a dis-

tance of twelve chains or thereabouts along the middle of the last-named drain thereby passing through Allam's Tunnel aforesaid and passing under the road called or known as Spaldinggate to the point where the same drain is joined by 'The Fresh Water' Drain and extending thence for a distance of twenty-four chains or thereabouts alternately eastward and northward along the middle of the last-named drain to the centre of the bridge or culvert which carries the road called or known as Barrel's-lane otherwise called or known as Chapel-gate over the same drain and extending thence northward for a distance of sixteen chains or thereabouts along the middle of the last-named road to the centre of the bridge which carries the same road over Lord's Drain and extending thence north-eastward for a distance of twenty-one chains or thereabouts to and along the middle of the last-named drain to the centre of Fulney Hall Bridge which carries the road called or known as Spalding-gate as aforesaid over the same drain and extending thence north-eastward for a distance of eighty-three chains or thereabouts along the middle of the last-named road to a along the middle of the last-named road to a point at the bridge or culvert which carries the same road over Wykemere Drain upon the boundary which divides the said Parish of Spalding from the Parish of Weston in the county and diocese aforesaid and extending thence first generally northward and then generally north-eastward along the last-mentioned boundary to its investion with the houndary tioned boundary to its junction with the boundary which divides the said Parish of Spalding from the Parish of Moulton in the county and diocese aforesaid and extending thence generally northward along the last mentioned boundary to its junction with the boundary which divides the said Parish of Spalding from the Parish of Algarkirk in the county and diocese aforesaid and extending thence south-westward along the last-mentioned boundary to its junction with the boundary which divides the last-named parish from the Parish of Surfleet aforesaid and extending thence first north-westward and then westward along the last-mentioned boundary to a point in the middle of the River Welland aforesaid and extending thence that is from the said lastmentioned boundary south-westward for a distance of seventy-one chains or thereabouts along the middle of the said river to the point where the boundary which divides the said Parish of Surfleet from the Parish of Pinchbeck aforesaid joins the boundary which divides the last-named parish from the Parish of Spalding aforesaid and extending thence still south-westward for a distance of ninety chains or thereabouts along the last-mentioned boundary, thereby continuing to follow the course of the River Welland aforesaid to the point near to Clayton's Farm where the said last-mentioned boundary diverges from the said river in an easterly direction and extending thence that is from the said last-mentioned boundary still south-westward for a distance of fourteen chains or thereabouts along the middle of the River Welland aforesaid to the point where the same boundary again enters the same river and continning thence still south-westward along the last-mentioned boundary thereby following in one part the course of the said River Welland and in another part the course of Vernatt's Drain aforesaid to the first described point in the middle of the lastly-named drain opposite to the middle of the northern end of the dyke upon the western side of the bank or roadway called or known as the Old Roman Bank as
