(No. 161.)—Adriatic—Port Bari-New Harbour.

(1.) Fixed Red Light on Breakwater.

THE Italian Government has given notice, that from the 1st December, 1877, a light has been exhibited from a small tower erected near the extremity of the breakwater in course of construction at the New Harbour, Bari:—

The light is a fixed red light, elevated 31 feet above the sea, and should be visible in clear weather from a distance of 5 miles.

The illuminating apparatus is dioptric, or by

lenses.

The light tower, circular, built of stone, and surmounted by an iron turret painted red, is situate 355 yards from the brick work Mole Head. Position as given, lat. 41° 8′ 10″ N., long. 16° 52′ E.

(2.) Bell Buoy at Entrance.

Also, that a bell buoy has been placed 218 yards westward of the light tower at the entrance of the New Harbour, Bari, to mark the submerged extremity of the breakwater in course of construction.

Ancona.

(3.) Discontinuance of North Mole Battery Light.

Also, that the fixed white light heretofore exhibited from the North Mole Battery, at Ancona, when the state of the sea prevented the fixed red light on the North Mole Head being shown, has been discontinued.

Note.—Vessels entering Ancona, on such rare occasions when the North Mole Head Light is not exhibited, must now be guided by the fixed green light on the South Mole Head, situate 66 yards in a S.S.W. direction from the extremity of the breakwater.

The South Mole Head should not be rounded at a less distance than half a cable.

Antivari Bay.

(4.) Temporary Discontinuance of Volovica Point Light.

Information has been received, that the fixed white light on Volovica Point, Antivari Bay, is not at present exhibited.
