WHEREAS the Governing Body of Westminster School, in virtue of the powers conferred upon them by "The Public Schools Act, 1868," and of every other power enabling them in that behalf, did, on the twentieth day of December, one thousand eight hundred and seventy-seven, make a Statute altering Clauses 3 and 10 of Chapter I of the Statutes approved by Her Majesty in Council, on the 3rd November, 1871, for regulating the government and constitution of the School:

And whereas the said Statute has been this day laid before Her Majesty in Council, the same is published in the London Gazette, in pursuance of the provisions of the said Act.

And notice is hereby given, that it is lawful for the bodies or persons authorized so to do, in that Act, within two months from the date of the publication of this notification, to petition Her Majesty in Council to withhold Her approval from the whole or any part of such Statute.

STATUTE A.

- I. This Statute shall take effect from and after the approval thereof by Her Majesty in Council.
 II. The Clauses mentioned in the first Column of the Schedule hereto, shall be read and construed as if the words set forth in the second Column were inserted in the stead of the words mentioned in the third Column, or were inserted in the place specified in the third Column, as the case may be :—

3	Candidates shall be admitted to this Examination under such regulations as the Governing Body shall prescribe from time to time. 10	And no boy who shall not have been entered and have attended at the School for such time as the Governing Body may fix by regulation from time to time, shall be admitted on the Foundation, unless he shall have been under fourteen years of age on the 25th of March preceding the entry of his name upon the Indentures.
