we the said Ecclesiastical Commissioners for England humbly represent that it would in our opinion be expedient that all those contiguous portions of the said new parish of Saint Peter Parkstone and of the said new parish of Saint Andrew Kinson, which are described in the schedule hereunder written, all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed should be united and formed into one consolidated chapelry for the said church of All Saints situate in Branksome Park as aforesaid and that the same should be named 'The Consolidated Chapelry of All Saints Branksome Park.'

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

## The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of All Saints, Branksome Park, being all those several contiguous portions of the new parish of Saint Peter, Parkstone, and of the new parish of Saint Andrew Kinson both in the county of Dorset, and in the diocese of Salisbury which said portions of such new parishes are comprised within and are bounded by an imaginary line commencing upon the county houndary which divides the new parish of Saint Peter Bournemouth in the county of Southampton and in the diocese of Winchester from the new parish of Saint Andrew Kinson aforesaid at a point in the middle of the Poole and Bornemouth turnpike-road such point being near to the house called or known as County Gate Lodge at the north-eastern entrance to the estate called or known as Branksome Park and extending thence north-westward for a distance of forty chains or thereabouts along the middle of the said turnpike - road (thereby following in part the boundary which divides the said new parish of Saint Andrew Kinson from the new parish of Saint Peter Parkstone aforesaid) to the point where the same turnpike-road is joined by Gas Works-road and extending thence northward along the middle of the last-named road for a distance of twenty-four chains or thereabouts, thereby crossing the line of the Poole and Bournemouth Railway, to the northern end of the same road at the wall or fence forming the south-eastern boundary of the buildings and premises called or known as the Bournemouth Gas and Water Works and extending thence north-eastward for a distance of four chains or thereabouts along the said wall or fence to the point where the same wall or fence joins the wall or fence forming the north-eastern boundary of the same buildings and premises and extending thence north-westward for a distance of twenty-chains or thereabouts along the last-mentioned wall or fence to the northernmost extremity of the said buildings and premises and extending thence in a direction due westward and in a straight line for a distance of seventeen and a half chains or thereabouts to a boundary-stone inscribed 'B. P. A. S. C. C. 1877, No. 1' and placed upon the eastern side of the cross road leading from Talbot village past the western side of the works called or known as the Bourne Valley Pottery into the road leading from Bournemouth to Constitution Hill, the said boundary-stone being distant thirty-one and a half chains from the junction of the said cross road with the last-described road and extending thence that is from the said boundary-stone first westward to the middle of the said cross road, and then south-westward for a

distance of twenty-eight chains or thereabouts along the middle of the same cross road to a point on the western side of the Bourne Valley Pottery aforesaid opposite to a boundary-stone inscribed 'B. P. A. S. C. C. 1877, No. 2,' and placed on the western side of the said cross road at the eastern end of the bank or fence forming the northern boundary of the houses and gardens called or known as Albert-villas and extending thence westward and in a direct line to such boundary-stone and continuing thence still westward for a distance of eleven chains or thereabouts along the last described bank or fence to its junction with the bank or fence forming the western boundary of the house and garden called or known as number 14 Albert-villas, and extending thence southward for a distance of four and a half chains or thereabouts along the last-mentioned bank or fence to a boundary-stone inscribed 'B. P. A. S. C. C. 1877, No. 3' and placed at the southern end of the same bank or fence on the northern side of the road leading from Bournemouth to Constitution Hill as aforesaid and extending thence southward and in a direct line for a distance of a quarter of a mile or thereabouts (thereby crossing the lastdescribed road and also crossing the boundary which divides the said new parish of Saint Andrew Kinson from the new parish of Saint Peter Parkstone aforesaid) to a boundary-stone inscribed 'B. P. A. S. C.C. 1877, No. 4, and placed on the north-western side of the Poole and Bournemouth turnpike-road aforesaid at a point opposite tothe middle of the north-western end of the road leading to the house which is called or known as the North Lodge and which forms the northwestern entrance to Branksome Park aforesaid and extending thence, that is from the lastdescribed boundary-stone south-eastward across the said turnpike-road to and along the middle of the road leading to the North Lodge as aforesaid for a distance of thirteen and a half chains or thereabouts (thereby crossing the line of the Poole and Bournemouth Railway aforesaid) to a point at or near to the said North Lodge, on the wall or fence forming the western boundary of Branksome Park aforesaid and extending thence first south-ward for a distance of one mile or thereabouts along the last-described park wall or fence, (thereby following the eastern side of the road leading from the Parkstone toll-bar towards Poole Harbour) and thence eastward along the same park wall or fence for a further distance of rather more than a quarter of a mile and finally southward along the same park wall or fence for a distance of half a mile or thereabouts to the southwestern angle of the said Branksome Park upon the cliff and continuing thence still southward and in a direct line over the said cliff to the southern boundary of the said new parish of Saint Peter Parkstone upon the shore of Poole Bay and extending thence eastward for a distance of one mile or thereabouts along the said shore thereby following in part the last-mentioned boundary, and in part the southern boundary of the new parish of Saint Andrew Kinson aforesaid to the county boundary which divides the said new parish of Saint Andrew Kinson from the new parish of Saint Peter Bournemouth as aforesaid and extending thence for a distance of one mile and ten chains or thereabouts first north-westward and then northward along the said county boundary (thereby following the eastern boundary of Branksome Park aforesaid) to the first-described point in the middle of the Poole and Bournemouth turnpike-road near to the County Gate Lodge where the said imaginary line commenced as aforesaid,"
