WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the vicarage of Saint George, Newcastle-under-Lyme, in the county of Stafford, and in the diocese of Lichfield, and to his successors, Incumbents of the same vicarage, one yearly sum or stipend of seventy-six pounds, such yearly sum or stipend to be payable out of the common fund under our control; and to be calculated as from the first day of November, in the year one thousand eight hundred and seventy-seven, and to be receivable in equal half-yearly

portions, on the first day of May and on the first day of November in each and every year. Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby grant and convey to the Incumbent of the vicarage of Fring, with the vicarage of Sherbourne annexed, in the county of Norfolk, and in the diocese of Norwich, and to his successors, Incumbents of the same united vicarages, all those pieces or parcels of land and hereditaments, together with the appurtenances thereunto belonging, particularly described in the schedule hereunto annexed, and now vested in us: and, also, all our estate and interest in the churchyard of the parish of Fring aforesaid, and the appurtenances thereunto belonging, which said churchyard is particularly described in the same schedule, to have and to hold the said pieces or parcels of land and hereditaments, and the said churchyard, together with their appurtenances, to the use of the said Incumbent and his successors for ever: Provided always, that the Incumbent for the time being of the same united vicarages, shall be entitled to receive from us, or on our account, the net amount of the rents, profits, and proceeds of the said pieces or parcels of land and hereditaments, for and in respect of the period intervening between the sixth day of June, in the year one thousand eight hundred and seventy-six, and the date of the publication of these presents in the London Gazette.
