And we hereby Order that the said Auditor shall, as soon as he conveniently can do so, in respect of the accounts of the said School District up to the twenty-fifth day of March, 1878, and thenceforth twice in every year, that is to say, as soon as may be after the twenty-ninth day of September and the twenty-fifth day of March, examine, audit, and allow or disallow, according to the laws in force for the time being in that behalf, the accounts of the Board of Management, and of their several officers who are by law liable to account to the said Auditor.

GENERAL ORDER of the Local Government Board : Suspending General Order relating to Election of Guardians, so far as regards Expenses :—

- West Derby Union.
- To the Guardians of the Poor of the West Derby Union, in the county of Lancaster ;—
- To the Churchwardens and Overseers of the Poor of the several parishes and places in the said Union ;—
- And to all others whom it may concern.

WHEREAS by a General Order, dated the 14th day of February, 1877, and addressed, among others, to the Guardians of the Poor of the West Derby Union, in the county of Lancaster, the Local Government Board prescribed Regulations relating to the election of Guardians of the Poor, and by Articles 32 and 33 of the said Order, provision is made for the remuneration to be paid to the Returning Officer for conducting such Elections ;

And whereas by an Order dated the 24th day of March, 1877, the Local Government Board suspended the provisions contained in those Articles, until the 1st day of March, 1878 ; and it is expedient that such provisions should be further suspended as hereinafter mentioned :
