upon all other sides, that is to say, on the west and on the south by an imaginary line commencing upon the boundary which divides the said township of Bolton from the parish of Saint Peter Bradford aforesaid at a point in the middle of Bolton-road and extending thence first south-westward and then southward along the middle of the said road for a distance of forty-five chains or thereabouts, to its junction with Wapping-road and extending thence south-eastward along the middle of the last-named road for a distance of twenty-six chains or thereabouts, to its junction with Lingard-street and extending thence northeastward and in a direct line for a distance of nine chains or thereabouts (thereby following the course of a proposed new street) to a point at the middle of the western end of Dacre-street and extending thence eastward along the middle of the last-named street for a distance of two and a half chains or thereabouts to its junction with Otley-road and with the street or road called or known as Tennyson-place and continuing thence still eastward along the middle of the last-mentioned street or road for a distance of twenty-three chains or thereabouts to its junction with Underdiffe-street, and extending thence northward along the middle of the last-named street for a distance of six and a half chains or thereabouts to its junction with Ripon-street and extending thence eastward, and in a direct line for a distance of forty-three and a half chains (thereby following the course of a proposed continuation of Ripon-street aforesaid) to a point at or near to the south-eastern angle of the house and grounds called or known as Crow Trees, in the middle of the Dudley Hill, Killinghall and Harrogate sturnpike-road, the said point being distant fourteen chains or thereabouts (measured along the last-named road) to the north-west of the junction of the same road with the Leeds and Bradford old road and continuing thence still eastward, and in a direct line across Bradford Moor, for a distance of nine chains or thereabouts to the boundary on the eastern side of the said Moor, which boundary divides the said parish of Saint Peter Bradford from the district chapelry of Saint Mary Laister Dyke aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Mojesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

HEREAS the Ecclesiastical Comissioners Act of the thirty-third and thirty-fourth years of it Her Majesty, chapter thirty-nine, and of the Acts therein mentioned duly prepared and laid before Her Majesty in Council a scheme, bearing date the and presentation arises or exists.

Calverley in the same county and diocese and eleventh day of April, in the year one thousand eight hundred and seventy-eight, in the words fol-

lowing, that is to say:—

"We the Ecclesiastical Commissioners for England in pursuance of the Act of the thirty-third. and thirty-fourth years of your Majesty chapterthirty-nine and of the Acts therein mentioned have prepared and now humbly lay before your Majesty in Council the following scheme for effecting a: transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (which said church and cure ere hereinafter called the said benefice) of Rhyl, in the county of Flint, and in the diocese of Saint Asaph, which said benefice of Rhyl was sometime part of the parish of Rhuddlan, in the same county. and diocese.

"Whereas the said advowson or perpetual right of patronage of and presentation to the said benefice of Rhyl is now vested in the vicar or incumbent for the time being of the vicarage of the said parish of Rhuddlan.

"And whereas a sum of one hundred pounds: sterling has been contributed and paid to the credit of our account at the Bank of England in augmentation of the endowment of the said benefice of Rhyl, and we have in respect of the said capital. sum, agreed and undertaken to pay to the vicar or incumbent of the said benefice of Rhyl (being duly licensed thereto) the yearly sum of three pounds six shillings and eight pence, so long as the said capital sum shall remain in our hands.

"And whereas the said capital sum of one hundred pounds sterling has been so contributed and paid as aforesaid upon the understanding and condition that a transfer of the whole advowson or perpetual right of patronage of and presentation to the said benefice of Rhyl, from the vicar or incumbent for the time being of the said vicarage of the parish of Rhuddlan (in whom the same is now vested as aforesaid), to the Bishop for the time-being of the said diocese of Saint Asaph shall be effected by the agency of us the said Ecclesiastical Commissioners for England.

"And whereas the Reverend Thomas Rowland, Clerk in Holy Orders, now vicar or incumbent of the said vicarage of the parish of Rhuddlan aforesaid is willing that the said advowson or perpetual. right of patronage of and presentation to the said benefice of Rhyl should be transferred to the Bishop for the time being of the said diocese of Saint Asaph as aforesaid and in token of his consent to the same proposed transfer the said Thomas Rowland has executed this scheme as here nafter mentioned.

"And whereas the Right Reverend Joshua now Bishop of the said diocese of Saint Asaph is the patron in right of, his See of the said vicarage of the parish of Rhuddlan, and as such Bishop and as such patron as aforesaid is consenting to the said proposed transfer and in token of such his consent (which consent by the Acts recited in the hereinbefore mentioned Act of the thirty-third and thirty-fourth years of your Majesty chapter thirtynine or by some or one of them is made necessary) he the said Joshua, Bishop of the said diocese of Saint Asaph, has executed this scheme as hereinafter mentioned.

"And whereas it appears to us that the transfer of the advowson or perpetual right of patronage of and presentation to the said benefice of Rhyl, which dis hereinbefore mentioned and hereinafter recomfor England have, in pursuance of the mended and proposed will tend to make better provision for the cure of souls in the new parish. of Rhyl, being the parish or district in or in respect of which the said advowson or right of patronage
