Any Officer, Seaman, Marine, or other person who may desire to receive his share from the Collector of Customs or of Inland Revenue within the United Kingdom, is required to intimate the same by letter to be addressed "On Prize Business, to the Accountant General of the Navy and Comptroller of Navy Pay, Admiralty, London, S.W." (enclosing his certificate of service or an attested copy thereof, excepting in the case of Commissioned Officers),—in which letter his own place of residence is to be precisely stated, as well as the place of the nearest Collector of Customs, or of Inland Revenue, from whom it would be convenient to receive such share of prize money.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction of five hundred pounds sterling, which has been paid to us in favour of the district chapelry and vicarage of Saint John the Evangelist, North Woolwich, in the counties of Essex and Kent, and in the diocese of Saint Albans, and in respect of which we have agreed to pay to the Incumbent of the same district chapelry and vicarage, and to his successors, a yearly sum of sixteen pounds thirteen shillings and four pence, do hereby, in pursuance of the Act of the twentyninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, grant to the Incumbent of the said district chapelry and vicarage of Saint John the Evangelist, North Woolwich, and to his successors, to meet such benefaction, one other yearly sum or stipend of sixteen pounds thirteen shillings and four pence, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the day of the publication of these presents in the London Gazette, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year : Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the yearly sum or stipend so payable out of our common fund, as lastly herein mentioned, or any part thereof, shall be annexed by us to the said district chapelry and vicarage, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the vicarage of Christ Church, South Banbury, in the counties of Oxford and Northampton, and in the diocese of Oxford, one yearly sum or stipend of one hundred and twenty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the eighth day of May, in the year one thousand eight hundred and seventy-eight, and to be receivable in four equal portions, on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year : Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said vicarage of Christ Church, South Banbury, shall be paid only upon the production to us, on or after each of the said lastly-mentioned days in each and every year of a certificate under the hand of the Bishop of the said diocese of Oxford, that an Assistant-Curate, duly licensed by such Bishop, has been employed within the parish of Christ Church, South Banbury aforesaid, during the quarter of the year then ended, and is in receipt of a salary after a rate of not less than one hundred and twenty pounds per annum; Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us
