The Queen has been pleased to grant unto John Page, of Royal York-crescent, Clifton, in the city and county of Bristol. Gentleman, and of Exeter College, in the University of Oxford, Master of Arts, son of Frances Darby, of Royal York-crescent aforesaid, widow and relict of Joseph Darby, Esquire, a General in the Royal Regiment of Artillery, deceased, by her former husband, Samuel Page, late of Hadley House, Hadley, in the county of Middlesex, Gentleman, also deceased, Her Royal licence and authority that he and his issue may. in compliance with a clause contained in a certain deed of indenture, bearing date the twelfth day of April last, take and henceforth use the surname of Darby, in addition to and after that of Page, and that he and they may bear the arms of Darby quarterly with those of their own family ; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect :

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

THE Board of Trade have received through the Secretary of State for Foreign Affairs a copy of a Despatch from Her Majesty's Ambassador at St. Petersburgh, stating that the Commander-in-Chief of the troops at Odessa has informed the Imperial Ministry for Foreign Affairs that merchant vessels are constantly causing injury, either by negligence or by intention, to the torpedoes which are sunken for the defence of Odessa. The Imperial authorities have consequently received orders to sue before the Tribunal for the exact amount of the injuries caused in each particular case.

MARINE HEALTH DECREE. No. 9.

THE Minister of the Interior, having taken the opinion of the Board of Health, decrees :--

From to-day, the health treatment of vessels arriving in Italian ports with foul bills of health, on account of yellow fever, is fixed as follows :----

ART. 1. Vessels which have made a safe voyage, and are satisfactorily healthy, will be subjected to
