THE Board of Trade have received through the Secretary of State for Foreign Affairs, information to the effect that a recent Royal Spanish Decree requires all vessels, of whatever class or nationality, which touch at intermediate ports between their port of departure and any port of Spain (including the Balearic Islands), to obtain for their Bill of Health the visa of the Spanish Consul resident at the last intermediate port, or, if there is no Spanish Consul there, the visa of the Consul of a friendly nation. Neglect to comply with this regulation renders the Captain of a vessel-liable to fine, and the vessel liable to quarantine on arriving in Spain (including the Balearic Islands).
