In the County Court of Cornwall, holden at Truro. In the Matter of Thomas Tuck Arnall and Thomas Arnall, of Redruth, in the county of Cornwall, Wire Workers, Bankrupts, and in the Matter of the separate Estate of the said Thomas Arnall.
