## THE FAIRS ACT, 1873.

## PRESTON (LANCASHIRE) HORSE FAIR.

WHEREAS a representation has been duly made to me, as Secretary of State for the Home Department, by the Town Council of Preston, Lancashire, as owners, that a Horse Fair has been annually held in that borough, commencing on Monday in the first full week in the month of January, and continuing during the remainder of such week, and that it would be for the convenience and advantage of the public that such Fair should be held on a less number of days, and that instead of being held as aforesaid, such Fair should in future be held on the Tuesday, Wednesday, and Thursday only, in the first full week in the month of January, in each year.

And whereas notice of the said representation, and of the time when I should take the same into

consideration, has been duly given to the Justices acting in and for the said borough of Preston, Lancashire, within whose Petty Sessional Jurisdiction the said Fair is held, and otherwise published in pursuance of "The Fairs Act, 1873:"

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the time for the holding of the said Fair should be shortened as proposed:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1873," do hereby order that the days shall be shortened for the holding of the Horse Fair which has been annually held in the borough of Preston, Lancashire, and that the said Horse Fair which has been hitherto held commencing on Monday, in the first full week in the month of January, and continuing during the remainder of such week, shall in future be held on a less number of days, and shall be held on the Tuesday, Wednesday, and Thursday only, in the first full week in the month of January, in each year.

GENERAL ORDER of the Local Government Board: Removing suspension of Art. 1 of Out-door Relief Prohibitory Order:—

West Ward Union.

To the Guardians of the Poor of the West Ward Union, in the county of Westmoreland;—

To the Churchwardens and Overseers of the Poor of the several parishes and places in the said Union;—

And to all others whom it may concern.

WHEREAS by an Order, dated the 14th day of September, 1874, the Local Government Board suspended the operation in the West Ward Union of the provisions contained in Article 1 of an Order, being a General Rule, dated the 21st day of December, 1844, addressed, among others, to the Guardians of the Poor of the said Union, until a further Order should be issued by the Local Government Board in that behalf;

And whereas it is expedient that the first above-recited Order should be rescinded:

Now, therefore, We, the Local Government Board, in pursuance of the powers given by the Statutes in that behalf, hereby rescind the said Order, dated the 14th day of September, 1874.
