#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by section one of "The Trade Marks Registration Extension Act, 1877," 40 and 41 Victoria, cap. 37, it is enacted that "In "so far as relates to the registration of trade "marks used in the textile industries, but not "turther or otherwise, section one of the Trade "Marks Registration Amendment Act, 1876, "shall be construed as if for the words 'from and "after the first day of July one thousand eight "lundred and seventy-seven," there were substi-"tuted the words 'from and after the first day of "January one thousand eight hundred and "seventy-eight, or such further time as Her "Majesty may by Order in Council determine.""

Whereas by Order in Council done at the Court at Windsor the 12th day of December 1877 present the Queen's Most Excellent Majesty in Council Her Majesty by and with the advice of Her Privy Council was pleased in accordance with the above-recited enactment to prolong till the 30th day of June 1878, the time for the registration of trade marks used in the textile industries:

And whereas it is deemed expedient that such time should be further extended beyond the said 30th day of Jane 1878: Now therefore Her Majesty by and with the advice of Her Privy Council is pleased in accordance with the aboverecited enactment to prolong till the 31st day of December 1878 the time for the registration of trade marks used in the textile industries.

THE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Act, 1869, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as

follows: 1. This Order shall take effect from and immediately after the twenty-ninth day of June, one thousand eight hundred and seventy-eight; and words in this Order have the same meaning as in The Animals Order of 1875.

 Notwithstanding anything in The Animals Order of 1875, or any other Order of Council, animals brought from a port or place in Her Majesty's possessions in North America, or from the United States of America, may be landed at the Basin or Dock and premises called or known as the Roath Basin of the Bute Docks, the property of the Marquis of Bute, situate at Cardiff, in the county of Glamorgan.
The Roath Basin or Dock and premises shall

3. The Roath Basin or Dock and premises shall not be deemed to be a defined part of a port within the meaning of The Animals Order of 1875, and the regulations contained in Chapter 16 (Animals in Defined Parts of Ports) of that Order shall not apply to animals landed under the provisions of this Order.

4. All the regulations contained in Chapter 14 (Foreign Animals generally) and Chapter 17 (Animals landed out of Defined Parts of Ports) of The Animals Order of 1875 shall apply, so far as the same are applicable, to animals landed under the provisions of this Order.
