Thornhill in the county of York and in the diocese of Ripon.

"Whereas at certain extremities of the said parish of Thornhill and of the consolidated chapelry of Flockton cum Denby Grange, in the said county of York and in the said diocese of Ripon which said extremities lie contiguous one to another and are described in the schedule hereunder written there is collected together a population which is situate at a distance from the several churches of such parish and consolidated chapelry respectively.

"And whereas it appears to us to be expedient that such contiguous portions of the said parish of Thornhill and of the said consolidated chapelry of Flockton cum Denby Grange should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of Saint Luke situate at Middlestown as aforesaid.

"Now therefore with the consent of the Right Reverend Robert Bishop of the said diocese of Ripon with the consent of Henry Savile of Rufford Abbey in the county of Nottingham Esquire the patron of the rectory of the said parish of Thornhill and with the consents of Sir John Pepys Lister Kaye of Eaton-square, in the county of Middlesex Baronet, of Henry William Stansfeld of Flockton Manor Wakefield in the said county of York Esquire, of the Reverend John Sharp Clerk in Holy Orders now Incumbent of the parochial chapelry of Horbury in the said diocese of Ripon of the Reverend Henry Josiah Day Clerk in Holy Orders now rector or Incumbent of the rectory of Saint Mary, Barnsley in the said diocese of Ripon and of the Reverend Joshua Ingham Brooke Clerk in Holy Orders now rector or incumbent of the said rectory of the parish of Thornhill aforesaid the patrons of the perpetual curacy of the said consolidated chapelry of Flockton cum Denby Grange (in testimony whereof they the said consenting parties have respectively signed and sealed this representation) we the said Ecclesiastical Commissioners for England humbly represent that it would in our opinion be expedient that all those contiguous portions of the said parish of Thornhill and of the said consolidated chapelry of Flockton cum Denby Grange, which are described in the schedule hereunder written all which portions together with the boundaries thereof are delineated and set forth on the map or plan her- unto annexed should be united and formed into one consolidated chapelry for the said church of Saint Luke situate at Middlestown as aforesaid and that the same should be named ' The Consolidated Chapelry of Saint Luke, Middlestown.

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Luke Middlestown:---

"All that portion of the parish of Thornhill in the county of York and in the diocese of Ripon wherein the present incumbent of such parish now possesses the exclusive cure of souls, and also all that contiguous portion of the consolidated chapelry of Flockton cum Denby Grange in the same county and diocese which two portions of the said parish and of the said consolidated chapelry taken together, comprise the four hamlets of Over Shitlington, Middle Shitlington, Nether

Shitlington, and Midgley, which said four hamlets are subdivisions of and together constitute the whole of the township of Shitlington."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fitty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of Her Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter filty-five, duly prepared and laid before. Her Majesty in Council a representation, bearing date the twenty-third day of May in the year one thousand eight hundred and seventy-eight, in the words following; that is to say :-

say :--"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the fiftyninth year of His Majesty King George the Third, chapter one hundred and thirty-four; of the Act of the second and third years of your Majesty, chapter forty-nine; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, have prepared, and now humbly lay before your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of Saint James situate at Woodhouse in the parish of Handsworth in the county of York and in the diocese of York.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint James situate at Woodhouse as aforesaid.

"Now therefore, with the consent of the Right Honourable and Most Reverend William Archbishop of York (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion be expedient that all that part of the said parish of Handsworth which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map cr plan hereunto annexed, should be assigned as a district chapelry to the said church of Saint James situate at Woodhouse as aforesaid, and that the same should be named 'The District Chapelry of Saint James, Handsworth Woodhouse.'

"And with the like consent of the said William Archbishop of York (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and
